## **DRE PUBLISHES NOTICE AND FAQs CONCERNING BROKER REQUIREMENTS**

**AB 1718 was passed this year and becomes effective on January 1, 2013. This changes the qualifying requirements for broker applicants.**

**Today DRE published a notice of this new requirement and also a brief FAQs to further explain their procedures. Most active brokers know that applicants for broker licenses are required to have a minimum of 2 years of experience as a full time licensed sales person within the previous 5 years along with certain education requirements.**

**Now, under AB 1718 applicants may still provide evidence of completion of 8 college level required courses along with the 2 years of experience. However, now the 2 years of experience requirement can be waived if the applicant has a degree with a major/minor in real estate from an accredited college/university.**

**Applications post marked after January 1, 2013 will be subject to the new provisions.**

**The FAQs makes the following points:**

- [Sorry lawyers] a Juris Doctorate degree does not fulfill the experience requirement for an accredited college/university.
- Official transcripts from the accredited school must be submitted to demonstrate the completion of the required course work.
- The 4 year degree does not automatically provide an exception from the completion of the 8 real estate courses.
